**Acceptance of Enrollment Contract:** The school will accept Enrollment Contracts for returning students only if tuition and fees for the current and prior school years are paid in full and all other obligations are current. If a student account has a past due balance, the school will first automatically apply any funds received to that balance. The school will not re-enroll a student until payments required by this contract are current. The enrollment process is complete and a student may attend class when the school has received a contract, deposit, and if applicable, a tuition assistance agreement.

### SECTION A: TUITION

- I agree to pay the annual tuition for the 2009 - 2010 school year.
- I agree to have my annual tuition set by a tuition assistance agreement for the 2009 - 2010 school year. This contract becomes binding upon completion of the tuition assistance agreement and a signed tuition agreement. In the event a tuition adjustment agreement cannot be reached, the \$1600 registration fee will be refunded.

**NON-REFUNDABLE REGISTRATION FEE: A non-refundable registration fee of \$1600 must be paid for each student for the '08-'09 school year along with the signed contract. The registration fee reserves the student's space in the class and is non-refundable.**

*Failure to submit a signed contract by March 13, 2009 and pay the appropriate registration fee may result in forfeiture of student's space in the class.*

I agree to pay the total annual tuition of \$ \_\_\_\_\_\* for the above named student in accordance with the payment schedule indicated below (please check one option). Please see "Terms and Conditions" for further details.

- ANNUAL: Tuition is due in full by June 15, or if enrolling after June 15, upon enrollment. A 3% discount applies if full\* annual tuition is paid by June 15, 2009. The registration fee of \$1600 is necessary to guarantee a space for the student. \*The 3% discount does not apply to students accepting any form of tuition adjustment.
- INSTALLMENTS: The annual tuition is paid in 12 monthly installments from July 2009 through June 2010. I agree to pay the service fee for Smart Tuition service.

### SECTION B: FEES

**REGISTRATION FEE** — A non-refundable registration fee of \$1600.00 is required for each student. The registration fee must be paid in full at the time of registration. Additional fees for services such as monthly instrument rental, after school sports, and field trips will occur during the school year. These are due prior to the service. Students whose account is not current will not be able to participate.

### SECTION C: MANDATORY PROGRAMS

**SCRIP PROGRAM** — Each family at the Santa Cruz Waldorf School is required to bring in \$250 in scrip income for the 2009-2010 school year (8/1/09-7/31/10). In the event that I do not accumulate the required amount by June 1, 2010

I will be billed for the balance due. Information about the scrip program is in the administrative offices.

My contribution of \$250.00 to the Scrip Program is enclosed.

**SECTION D: CONSENT FOR IMAGES AND PICTURES IN SCHOOL PUBLICATIONS**

**SECTION E: TERMS AND CONDITIONS**

- 1) This enrollment contract covers the entire school year. There is no discount, refund, or other allowance for absence, dismissal, or withdrawal except as provided below.
- 2) In the event of withdrawal subsequent to the first day of school, the school requires 60 days written notice. If written notice is given less than 60 days prior to the date of withdrawal, the school requires that tuition be paid for 60 days from the receipt of notification, calculated on a per diem basis. Any remaining paid tuition in excess of these requirements will be refunded.
- 3) In case of dismissal, the contract is terminated as of the date of dismissal. Account will be calculated on a per diem basis; prepaid tuition in excess of enrolled time to date of dismissal will be refunded.
- 4) If it is necessary for the school to take legal action to collect any amounts payable under the terms of this contract, the prevailing party shall be entitled to reasonable attorney's fees and costs as determined by a court of proper jurisdiction.
- 5) IF TUITION BECOMES 60 DAYS DELINQUENT YOUR CHILD(REN) WILL NOT BE ABLE TO ATTEND CLASS.
